

Dear Church Family,

STAFF CHANGES

It is with a heavy heart I am resigning as Pastor of Family Ministry here at St. Paul's Evangelical Church. My time here has been marked by many difficulties, as the church has faced numerous challenges in the 2+ years I have been on staff and I have dealt with significant loss and hardship within my own family as well. Unfortunately, I have reached a point where I cannot continue to serve here in good conscience.

I hope that my resignation will make space for the repentance and reconciliation that needs to take place for the witness of St. Paul's to thrive in the name of Christ. My singular recommendation moving forward is for the church to submit itself to a Christ-centered, independent investigation through an accredited organization. Additionally, I thought it would be helpful to provide you with some responses to some of the most common questions I am getting at this time.

- **1. When will I be finishing my time at St. Paul's?** My time at St. Paul's will officially end on either June 14th or shortly after I find a new job. Until my time ends, I will continue to serve with Cultivate Kids and Cultivate Teens and in any other ways I can be of service to those here at St. Paul's.
- 2. What do I plan on doing next? This is a harder question to answer as I really do not know exactly what I want to do. I am focusing my efforts on jobs within the social services and non-profit sectors. I do not plan on looking at any church-specific positions as I need some time for myself and my family to heal from a very difficult season of ministry over the past few years. You can pray for God to provide the right job for myself and my family in the coming months as I continue to look at other opportunities and consider what God may be calling me to next.

I have grown to cherish this unique church. You have generously provided for the needs of my family and myself. You all have stepped up in some big ways during my time here and have brought me much encouragement and support as I have endeavored to help our church reach the community around it. I am especially grateful for the dedication shown by so many volunteers to serve with Cultivate Kids on Wednesday nights, Children's Church and Sunday School on Sunday mornings, and Cultivate Teens on Sunday nights. As my time here comes to a close, I want to again, say "thank you" to everyone here at St. Paul's for the love, support, generosity, and care during my time here. I pray God brings to St. Paul's the right person to lead this church forward.

Pastors' Report: Pastors were not in attendance.

Mike Shields, EFCA Central District:

Mike Shields entered the room and asked to speak to the Elder Board. He has been in contact with Pastor Don Price advising him a letter will be sent from Tom Harris, Executive Director of Interim Pastoral Ministry, recalling him from his position as Interim Pastor of St. Paul's Church. Mike was very encouraging to the Elder Board. On March 26, Mike will be a guest speaker, with a Q&A session following this worship service. He stressed, we at St. Paul's, must be in a position to offer and receive forgiveness and not lay blame at anyone's feet. Todd Brooks will be available to fill the pulpit during April and May. Elders and Deacons will participate with IPM in identifying an Interim Pastor with the gifts of Teaching, Healing and Shepherding.

Old Business:

We will, with the aid of Todd Brooks and a chosen mediator, continue with conciliation sessions with the Deacons. Discussion on a proposed contemporary worship was put on hold until the April meeting.

New Business:

An announcement will be put in the church bulletin soliciting names for a nominating committee. Joyce Lindstrom will be the Elder representative on the committee. Time for quarterly listening session between the Elders and congregants will be established at the April meeting. Announcements will be put into the Sunday bulletins offering anointing and laying on of hands, by the Elders, to any congregants who have a need. Congregants will be invited to the Shepherding Meeting on Saturday, March 25, to be in earnest prayer for St. Paul's.

Deacons' Report:

The Deacons were informed, prior to entering the Elder meeting, about Pastor Don being recalled. David Brewer, on behalf of the full Elder Board, asked forgiveness from the Deacons and they were invited to join mediation sessions. The General Fund has an \$81,000 deficit and they are working on the best way to pay the monies required to settle the law suit. A Town Hall Meeting will be called for Sunday, March 26, to give the congregation an update.

MISSION TEAM NEWS

Disaster Relief

Does it seem like the number of disasters in this world, both natural and manmade, are multiplying almost on a daily basis? Do you want to provide financial assistance in disaster relief, but aren't sure what organizations are Christ-based and effective in carrying out this important mission? Your Mission Team did some research on this topic about two years ago in order that we would have solid information for decisions on providing St. Paul's funds to support those hurting from war, floods, hurricanes, tornadoes and other catastrophic events. We thought it would be helpful to pass on that information to the congregation.

There are many, many charitable organizations out there that help hurting people around the world. We found that two of the most effective in mobilizing quickly and getting the needed aid to a location anywhere in the world are Convoy of Hope and Samaritan's Purse.

Convoy of Hope:

Convoy of Hope was founded in 1994, and is based in Spring-field, MO. It is a faith-based organization focused on children's feeding initiatives, community outreach and disaster response. Convoy of Hope partners with local churches, businesses, civic organizations, and government agencies to get help to communities around the world. In 2022 alone, the organization served over 4.5 million people through disaster relief for 39 disasters globally and 36 in the US. Convoy of Hope was immediately on the ground after the tornadoes in Mississippi this past weekend, arriving within a day with truckloads of supplies. Convoy of Hope is accredited by the Evangelical Council for Financial Accountability and has a four-star rating from Charity Navigator.

Samaritan's Purse:

Many of you are familiar with Samaritan's Purse through our annual Operation Christmas Child shoebox drive. Samaritan's Purse is a nondenominational evangelical Christian organization providing spiritual and physical aid to hurting people around the world. Since 1970, Samaritan's Purse has helped meet needs of people who are victims of war, poverty, natural disasters, disease, and famine with the purpose of sharing God's love through His Son, Jesus Christ. The organization serves the Church worldwide to promote the Gospel of the Lord Jesus Christ. Like Convoy of Hope, Samaritan's Purse is already on the ground in Mississippi. The organization's capabilities and focus are wide-ranging. The massive logistics of disaster relief is one area of ministry, as is Operation Christmas Child. However, the organization mobilizes medical missions around the world, conducts marriage enrichment retreats for hurting veterans and their spouses, and so much more. Samaritan's Purse brings together volunteers from around the country to support disaster relief her in the US, which is another way you can help beyond financial donations. Samaritan's Purse has a clear statement of faith, and their response to people who ask why they work in crisis areas of the world, the answer is always the same: "We have come to help you in the Name of the Lord Jesus Christ." Our ministry is all about Jesus—first, last, and always. As the Apostle Paul said, "For we do not preach ourselves, but Jesus Christ as Lord, and ourselves as your servants for Jesus' sake" (2 Corinthians 4:5, NIV).

We hope you find this information useful. Again, there are many worthy, faith-based organizations doing great work, and your support will be appreciated no matter where you give it. These are two that have the logistics, partnerships and knowhow to get aid where it is needed fast and effectively.
